

## AMAZON CONNECT VIRTUAL SUMMIT 2020 CONTEST TERMS AND CONDITIONS

This contest, namely "Amazon Connect Virtual Summit 2020 Contest" ("**Contest**") is provided and made available to you by Amazon Seller Services Private Limited ("**Amazon**") in relation to the event namely 'Amazon Connect Virtual Summit 2020' ("**Event**") conducted by Amazon and available on <https://vconfex.com/microsite/amazon-connect> ("**Event Page**"). . Please read these terms and conditions ("**T&Cs**") before entering the Contest.

You agree that, by participating in this Contest, you will be bound by these T&Cs, and in any other terms and conditions that may be prescribed in relation to the Prize(s) (as defined hereinafter). You acknowledge and agree that you satisfy all Contest eligibility requirements as provided herein below.

These T&Cs are in addition to the terms to which you agree by participating in the Event and using the seller account for transactions on [www.amazon.in](http://www.amazon.in) ("**Amazon.in**") (if applicable), including but not limited to Amazon Services Business Solutions Agreement executed between you and Amazon (collectively, "**Amazon Terms**"). To the extent the any of the Amazon Terms are inconsistent with these T&Cs, these T&Cs will prevail with respect to the Contest only.

For the purposes of these T&Cs, wherever the context so requires "You" or "Your" shall mean any natural person who is a participant in the Contest.
